I'm looking for a resident or residents who would be interested in writing a column in our newsletter on happenings at the lake, any history of Lake Jennie, or other items of interest..



TIPS FOR LAKEFRONT HOMEOWNERS

Clean lakes need healthy lakeshores and healthy lakeshores need you! 1. Wash your car or truck on the grass rather than the driveway to help filter containments. Use a small amount of no-phosphate detergent 2. Mow lawn tall, ideal height for healthy grass is 2.5-3 inches to filter run off and fertilize less to keep out pollutants.

3. Use zero-phosphorus fertilizer and any fertilizer spilled on sidewalks or roads should be immediately cleaned up by sweeping and removal. Do not let fertilizer wash into gutters or lawns.

4. Water your lawn (<1") after fertilizing, but do not allow water to run off into street or lakes.

5. Never apply fertilizer to frozen ground.

6. When mowing lawns do not direct clippings into the street, sidewalk, or lake.

7. Grass clippings, leaves, and other plant debris should be removed as soon as possible from street gutters, sidewalks, and driveways.

8. Grass clippings can be an effective way of recycling nutrients. Leaving clippings on the lawn provides nutrients for your lawn and greatly reduces the need for additional fertilizers.

9. For lakeshore owners, landscaping practices that force runoff to filter through the soil before entering the lake are suggested:

a. Leave a "buffer zone"- a strip of unmanaged grasses or natural vegetation to grow around the shoreline. This vegetation will help prevent soil erosion from the shore land and will also remove and retain some of the nutrients that would otherwise enter the lake.

b. Construct and maintain a modified berm along the shoreline. This is best described as a slight hump in the ground that runs near parallel to the shoreline. This rise in the ground will serve as an obstacle to the rapid and direct nutrient-rich runoff into the lake.

10. Remove pet waste regularly from your lawn. Pet waste should be disposed of with your garbage. Pet waste contains nutrients and pathogens that can contaminate surface water.

12. Direct rain gutters to lawn to soak in versus hard surfaces like driveways and sidewalks to reduce runoff.

13. Make sure your septic system is in compliance to prevent ground seepage into lake.

14. Use no- or low-phosphorus detergents and use soaps and other cleaning agents carefully-never allow them to wash into a lake, stream or wetland.



2021 Curly-Leaf Pondweed Treatment Areas

LJIA looked into using Diquat Aquatic Herbicide instead of Aquathol for the 2021 lake treatment season. Since we have been getting Walleye yearlings instead of fry for stocking purposes we could use the low cost Diquat. The savings resulted in treating 115 acres instead of 25 acres. The red dots are active Curly-Leaf Pondweed. White dots no Curly-Leaf Pondweed
