Update from Limnopro next meeting.

MCAL Report:

Weed Study/Grants:

Meeting last week grants were approved. AIS for \$8500, Water quality level \$5000.

MCAL wants at least 10 lakes grouped together to do water testing submitted to MLAB.

They will cut the cost down for us. Can we join that group? Nass has details. Do we have limitations to do this because we were getting reimbursed for sampling with Limnopro and we would do with them? Will cost us \$250 the county will reimburse us.

Need to pay our MCAL dues. Motion to approve \$250 for water testing (suchy disc, level measuring) with MCAL group. All in favor. Dick Nesvold, Laura Osborne.

Limnopro quote \$8550 his, \$4450 equipment. Total \$13,000. Motion to move forward with Limnopro. All in favor. Grant for water quality (grant is \$5000) will get applied to this cost. He gave us links to all the equipment we need pricing, etc. Ryan thinks between himself and Kent they can get around 5 days done each week – Limnopro 2020 states lake level measurements daily if possible.
